Investment Objective

To provide investors with the potential for capital growth through investment primarily in the securities of companies involved in the exploration, development and production of energy, predominantly within the uranium industry. Up to 30% of the value of the Company's investment portfolio may be invested in other resource-related companies from outside the energy sector.

Investment Manager Comment²

Despite being a quieter week for sector news flow, the commodity price continued to tick up, with the spot price up 2.9% and the Fund NAV rising a similar 3.1% over August. Early in the month, whilst visiting an Exelon facility, US Energy Minister Rick Perry commented that US nuclear power represents one of the most reliable and clean sources of energy. The statement may provide impetus for Ohio and Pennsylvania to amend state support for reactors and introduce similar policies to those adopted by New York, New Jersey, Illinois and Connecticut. However, uncertainty regarding the ongoing Section 232 petition in the US has so far stymied US utility buying which has remained lacklustre. Elsewhere, India announced progress on a project for construction of six reactors at a site in Jaitapur, Maharashtra.

Four Japanese utilities are reportedly discussing a nuclear alliance, including TEPCO, Chubu, Hitachi and Toshiba. This would create a joint engineering company that would reduce costs but may also help Chubu and TEPCO to restart their reactors which are subject to local opposition.

The physical uranium fund Uranium Participation Corp announced it had increased its holding by 675k lbs, having acquired material on the spot market.
